Dear Senator Case,

Nixon made my Christmas really a gala one by including me on the enemy list that he and Erlichman put together. I howled with glee when first apprised of my new status and tried to answer reporters questions as to why me. Didn't really succeed in coming up with a real answer as I hadn't given that much money, held no official campaign title or responsibility, etc. and attributed it to perhaps my big mouth and hot electric typewriter that peppers all of you regularly with my imprecations and complaints. Perhaps he doesn't appreciate the lack of loyalty because of my position as state co-chairman for Nixon in 1960 while I was working full time at your office in Newark as a volunteerwith Millicent f

fenwick and for Sam Zagoria. To say that I became violently antiwar and anti-Nixon in subsequent years would be a gross understatement! But an abstract artist and sometime writer seems like an odd member of such a distinguished group.

It truly is not funny tho and the perversion of the IRS to what apparent end is an evil and Nazi-like approach to politics and people. What were they going to do to us eventually? It reeks of thought control and rubbing out of the opposition so that perhaps King Richard could reign in perpetuity.

I think it incumbent upon you to defend the constitution and your constituents on these points and attempt to find out what the genesis of this list was. I think too, that if you have the opportunity to vote for conviction on a bill of impeachment that you

rmember this illegal act which ranks with the Ellsburg burglary, the Watergate burglary and heaven knows how many others. But this is part of his pattern of illegality which he and John Mitchell carefully orchestrated from the beginning and the little green leather campaign plan had it all in their. There is not one act worthy of his conviction but many if we would stop talking double-speak and take the gloves off and used plain talk the way Lowell Weicker does.

I do hope you can dig up some answers for me as to why and how as if we can't look to you for protection and the president undertakes to harrass individual citizens what has this country and its constitution come to? If we don't proceed to the denouement of the impeachment drama there will be precious little left of this country to pass on to succeeding generations. Enclosed is a copy of the letter I have been sending to the thousands of people who have been in touch with me concerning possible impeachment of the President.

I have no idea what the genesis of the enemy lists was, but it was a childish thing to do. Of more concern is the attempted misuse of IRS, attempts which were apparently unsuccessful. In any case, both the Constitutional Rights Subcommittee of the Judiciary Committee and our Foreign Relations Committee are looking into the whole question of taps and investigations of particular persons by various executive agencies. The Watergate committee is also, I believe, examining the Ellsberg case. Out of all this ought to come some recommendations and possibly legislation to provide more effective protection of individual rights.
