# TWELVE REASONS

WHY WOMEN SHOULD VOTE

- 1. BECAUSE it is the foundation of all political liberty that those who obey the Law should have a voice in choosing those who make the Law.
- 2. BECAUSE most Laws affect women as much as men, and some Laws affect women more than they do men.
- 3. BECAUSE the Laws which affect women are now passed without consulting them.
- 4. BECAUSE Laws affecting children should be regarded from the woman's point of view as well as the man's.
- BECAUSE questions affecting the home come up for consideration in every session of the Legislature and of Congress.
- 6. BECAUSE women have experience which should be help-fully brought to bear on legislation.
- 7. BECAUSE to deprive women of the vote is to lower their position in common estimation.
- 8. BECAUSE the possession of the vote would increase the sense of responsibility among women toward questions of public importance.
- 9. BECAUSE public-spirited mothers mean public-spirited sons.
- 10. BECAUSE large numbers of intelligent, thoughtful, hard-working women desire the franchise.
- 11. BECAUSE the objections raised against their having the franchise are based on sentiment, not on reason.
- 12. BECAUSE to sum up all reasons in one—IT IS FOR THE COMMON GOOD OF ALL.

# NEW JERSEY SHOULD RATIFY THE FEDERAL SUFFRAGE AMENDMENT:

# BECAUSE

it is in accordance with the law. The Constitution of the United States provides that when an amendment shall have received the votes of two-thirds of the members of the U. S. Senate and House of Representatives, it shall be referred to the LEGIS-LATURES of the several States for ratification, and when three-quarters of them shall have voted to ratify it, it shall become the law of the land. THE EIGHTEEN PREVIOUS AMENDMENTS HAVE ALL BEEN RATIFIED IN THIS WAY.

#### BECAUSE

a referendum to the voters would not be legally binding upon the Legislature, although it would cost the State as much money, and the suffragists as much time and effort as if it were a binding referendum.

#### BECAUSE

a real referendum is to be taken this Fall, when the voters vote for candidates who favor or oppose woman suffrage. The suffragists will inform the voters how every candidate stands upon this question.

# BECAUSE

the election laws of New Jersey make inadequate provision for safe-guarding the vote at special elections. In 1915 the election was held on a registration day, and thousands of men voted immediately after registering, thus giving no opportunity for checking up their addresses or right to vote. The police canvass before the general election that year removed from the books as "illegally registered" the names of thousands of men, but all of those men had had an opportunity to vote on the suffrage amendment.

## BECAUSE

within two months of the passage of the suffrage amendment by Congress fourteen State Legislatures ratified, i. e., those of Illinois, Wisconsin, Michigan, Kansas, New York, Ohio, Pennsylvania, Massachusetts, Texas, Iowa, Missouri, Arkansas, Montana and Nebraska. There is every likelihood that thirty-six Legislatures (exclusive of New Jersey) will have ratified before next Spring, thus enfranchising all the women of the land, so that if New Jersey delays ratification until 1921, its women will be enfranchisement by the men of other States. This will be bitterly humiliating to the women of New Jersey, whose intelligence, loyalty and patriotism merit better treatment.

## BECAUSE

there has been a tremendous change in sentiment since 1915. New York defeated suffrage then by exactly the same percentage as New Jersey, 48 to 42%; but in New York the Constitution allowed the question to be voted on again two years later and then suffrage carried by 100,000 majority. Since 1915 State after State has voted for woman suffrage so that today women have full suffrage in Washington, Oregon, California, Idaho, Nevada, Arizona, Utah, Montana, Wyoming, Colorado, South Dakota, Kansas, Oklahoma, Michigan, and New York; and Presidential suffrage in North Dakota, Nebraska, Minnesota, Iowa, Missouri, Wisconsin, Illinois, Indiana, Tennessee, Maine, Vermont, Rhode Island, Ohio, Texas, and Arkansas. NO STATE WHICH HAS WOMAN SUFFRAGE HAS EVER TRIED TO REPEAL IT.

#### BECAUSE

over 16,000,000 women in thirty States can now vote for President, thus giving the balance of power to the West and Middle West. Does New Jersey wish an equal voice in the 1920 election? Then the Federal Amendment must be ratified next Winter.

# BECAUSE

Women have full suffrage in these countries outside the United States: Great Britain, Canada, Australia, New Zealand, British South Africa, Norway, Sweden, Finland, Iceland, Denmark, Holland, Czecko-Slovakia, Hungary, Poland and GER-MANY. Did we fight for democracy only to give it to the women of Europe? Shall New Jersey women be penalized for being Americans?
